

Dear Friends of CASA.

It's difficult to articulate the challenges everyone has faced over the past two years – I'm sure many of you have dealt with loss, anxiety and other hardships. We've all struggled to adapt to our "new normal," which seems to change on a regular basis.

But just imagine trying to navigate the realities of the pandemic as a child who has experienced abuse and neglect.

Unfortunately, there's **537** children experiencing abuse and neglect in our community (Will and Grundy counties – River Valley). They are the innocent victims of domestic violence, substance abuse and countless other issues that plague our society. And too many of these children are voiceless.

Thanks to the continued generosity of supporters like you, our incredible staff of social workers and **124** selfless volunteers serve as the voice to **400+** children who experience abuse and neglect in River Valley every single day. They are **advocates** – helping these children recover from the traumas they've endured and ensuring they find safe, permanent and loving homes they deserve.

But there's still a considerable number of children in our community that need a voice. And we can help.

Before I joined the CASA of River Valley Board of Directors, I served as a volunteer advocate for a brief period. I saw first-hand the incredible impact CASA, through our staff and volunteers, can have on the lives of these children – in courtrooms, foster homes and classrooms. Most importantly, I saw that impact in the eyes of the children I advocated for, as I helped them navigate our foster care system.

Those children I advocated for buoy my commitment to ensure every single one of those **537** children that have experienced abuse or neglect in our community also have a voice. But we urgently need your help.

I hope you'll consider a **one-time or recurring gift** – \$1,000 allows us to advocate for one child for an entire year. Or consider lending your time and talent to become a volunteer. Please help us give a voice to every child that has experienced abuse and neglect in River Valley.





#### Percentage age groups served



#### Children We Helped Came to Us as a Result of





# A BRIGHTER FUTURE CAN "CHANGE A CHILD'S STORY"

When CASA first met Isobel, she was 2 years old. Her mother, Maria, almost died after a vicious beating from her boyfriend, who was Isobel's father. DCFS became involved, and Isobel was placed in foster care.

Maria was a fighter, and steadily improved in the hospital until she was able to be released. It was clear to CASA that Isobel and Maria had a strong bond; when Maria showed up for her visits with Isobel, Isobel's eyes lit up and she would run to her mother for hugs. Maria immediately began working her list of services she had to complete to regain custody of Isobel. She loved to tell CASA about all of the things she learned in her domestic violence victim's counseling and her parenting classes. It was clear that Maria was determined to build a better life for herself and her daughter.

Maria bravely agreed to press charges against her boyfriend, and eventually he was sentenced to 5 years in prison. Maria was overjoyed at this news, stating that she knew she and her daughter would be safe now that he was gone. CASA provided Maria with information on the Violent Crimes Victim's Assistance fund, and helped her to fill out the forms. The money

she would receive would further help Maria and Isobel to overcome their past trauma and look forward to a brighter future.


After Maria completed her services, both DCFS and CASA agreed that it was time for Isobel to be placed back with her mother. However, Isobel's father attempted to fight Isobel being allowed to return home to Maria, stating he wanted Isobel to be placed with his family instead. When the Judge wasn't sure what to do, Isobel's CASA volunteer was put on the

stand to testify. Thanks to CASA's testimony, the Judge stated that it was clear that Maria had completed everything she needed to do, and that Isobel should be returned to her care.

When Maria moved into her new apartment, CASA was able to collect donations to help Maria and Isobel to turn their new apartment into a warm and welcoming home. Both Maria and Isobel received beds and mattresses, and thanks to CASA's wonderful network of donors, we were also able to provide them with clothing, kitchenware, toys, and personal care items.

While Isobel handled being in her foster home well, and her foster parents were fantastic, it was clear to CASA that Isobel's heart was aching to be back with her mom. As Isobel adjusted to being back with her mother, her personality began to shine more than ever before. During CASA's visits, she was always running, dancing, and laughing. Now, Maria and Isobel continue to do phenomenally well. Maria has just registered to begin cosmetology training, and Isobel is thriving in preschool. Thanks to their CASA volunteer, Maria and Isobel will share a happy future together.

Children deserve to live in a home where they are loved and cared for by their parents or forever family. A Court Appointed Special Advocate (CASA) is a trained volunteer who is appointed by the Juvenile Court Judge to represent the best interests of a child who has experienced abuse or neglect.

CASA volunteers are appointed as Guardian ad Litems (GALs) and act as the eyes and ears of the Judge by documenting each child's circumstances and making recommendations for services and permanency. The ultimate goal of the CASA is to help ensure that every child lives in a safe and permanent home. This could mean reunification with the parents, placement with relatives, or adoption by a loving family.

#### What are the requirements to be a CASA/GAL?

- Anyone 25 years of age or older with good communication and writing skills is welcome to apply (bilingual volunteers needed!)
- Pass DCFS and criminal background checks
- Attend 30 hours of training

#### What are the expectations of a CASA/GAL?

- · Visit children at least monthly
- Interview everyone involved in the child's life
- Prepare written court reports with findings and recommendations
- Complete 12 hours of in-service training annually
